

ARIDO 2019 - 2021

PROFESSIONAL DEVELOPMENT PROGRAM REQUIREMENTS

The Professional Development cycle will run for a two-year period from July 1, 2019 – June 30, 2021.

- The PD requirement applies to Intern, Registered, and Educator members.
- Members must complete 12 hours in total over two years.
- There are two education areas members must meet: **Health and Safety (HS)** and **General Education (GE)**. A minimum of 4 hours must be Health and Safety, and up to 8 hours can be General Education.
- ARIDO is no longer mandating IDCEC accredited education. Professional, business, technological, management and other personal development courses that directly relate to your genre of interior design practice are accepted regardless of accreditation or providers.
- Members can report their education activities in the ARIDO reporting system or the IDCEC system.
- **ARIDO will not reject any education a member completes that is accredited by IDCEC.** However, IDCEC approved HSW courses will not necessarily qualify for ARIDO's Health and Safety (HS) requirement if the activity does not meet the HS criteria indicated on page 2 of this guide.

ACCEPTANCE CRITERIA

A minimum of 4 hours must be Health and Safety, and up to 8 hours can be General Education.

To determine if a course or seminar qualifies as Health and Safety or General Education – follow the acceptance criteria below. Course providers offering Health and Safety education will not necessarily qualify for ARIDO's Health and Safety requirement.

Structured Learning

Completing a course or seminar, either in-person or distance learning, in one of the learning topics listed on page 2. Courses taken at a college or university that are not related to meeting the minimum education requirement will qualify.

(1 hour of education = 1 CEU Unit)

T

Instructing/Teaching

Development of a course or seminar, either in-person or distance learning, in one of the learning topics listed on page 2.

(Max 1 credit claimed per year / Max 2 credits per cycle)

R

Research

Conduct research or write a research paper on a topic related to one of the learning topics listed on page 2 or a topic related to the profession.

(Max 1 credit claimed per year / Max 2 credits per cycle)

W

Writing

Writing articles or books related to one of the learning topics listed on page 2 or a topic related to the profession.

(Max 1 credit claimed per year / Max 2 credits per cycle)

P

Presenting

Development of a presentation related to one of the learning topics listed on page 2 or a topic related to the profession.

(Max 1 credit claimed per year / Max 2 credits per cycle)

V

Volunteering

Committee and/or Board Participation that furthers the profession of interior design or in the area related to one of the learning topics listed on page 2.

(Max 1 credit claimed per year / Max 2 credits per cycle)

M

Mentorship

Serving as a mentor, sharing sessions with new designers, co-op student training in studio.

(Max 1 credit claimed per year / Max 2 credits per cycle)

M

Mentoree

Participate in mentorship program where you are mentored by a Registered member. Hours cannot be applied toward the supervised work experience hours needed to become a registered member.

(Max 1 credit claimed per year / Max 2 credits per cycle)

REPORTING QUICK STEPS

REPORTING TO THE ARIDO SYSTEM

Click '+ Add Professional Development' and complete the required information:

1. Provider or Organization
2. Course Title
3. PD Activity, (Structured Learning, Writing, Research, etc) select the drop down arrow and choose the PD Activity
4. PD Type, (General Education or Health and Safety) select the drop down arrow and choose the PD Type
5. PD Level, (Basic, Intermediate, Advanced) select the drop down arrow and choose the PD Level
6. Select date of completion
7. Add comments
8. Upload a certificate, click and drop a file or click on the blue rectangle to select a file
9. Click 'Add'

The credit will have the red 'NOT SELECTED' tag.

Submitting the PD credits

FAQ

To whom does this apply?

ARIDO currently requires Registered, Intern and Educator members to meet the continuing education requirement in order to maintain their memberships.

All three membership levels are required to meet the same amount of continuing education.

Who is not required to complete PD?

Retired, Life, Honorary and Student members are not currently required to meet the continuing education requirement in order to maintain their memberships.

Fellow members who have retired from the practice of interior design are not required to meet the PD requirement.

Inactive Status members

Members who are temporarily inactive due to parental or medical leave will not be required to complete continuing education during their leave of absence.

The total amount of PD required will be pro-rated to reflect the duration of absence.

What no longer qualifies?

- Association membership
- Attending trade-shows such as IDS
- Self-guided tours, showroom tours
- Work experience, or internships to meet ARIDO membership requirements or to complete education programs.

How will ARIDO enforce compliance?

At the end of the 2019-2021 PD cycle, ARIDO will conduct a random audit its eligible membership and ensure that the members selected in the audit have complied with the requirement.

Audited members who are not in compliance may be subject to termination of their membership due to non-compliance.

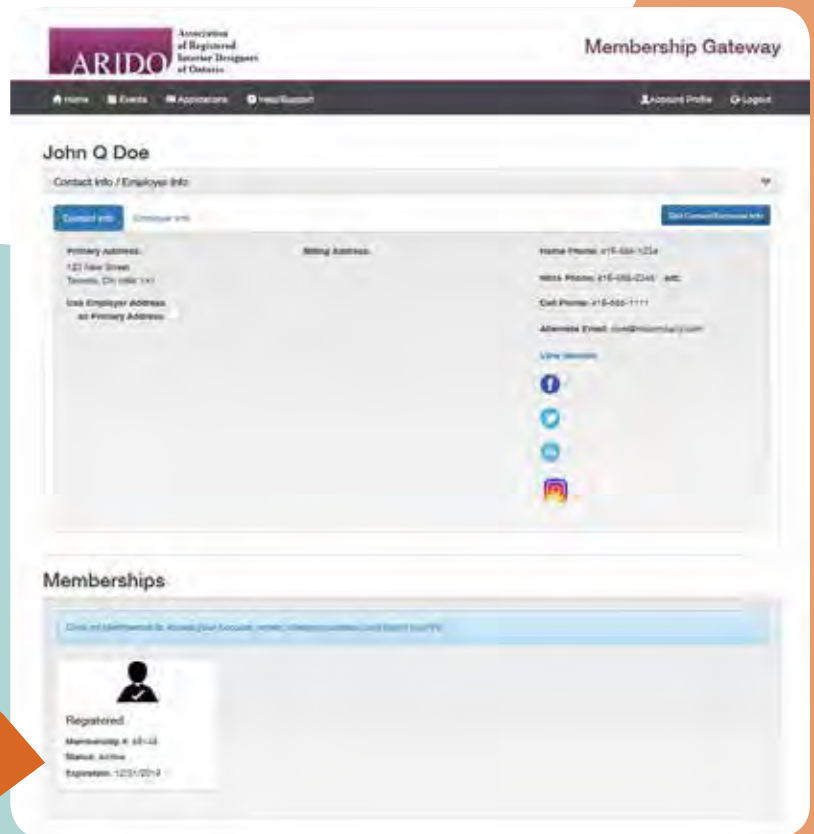

STEP 1 - ACCESS THE ONLINE REPORTING SYSTEM

- Visit the ARIDO website (arido.ca)
- Click '**Membership Gateway**'
- Enter your email, and password and click sign in

STEP 4 - ADDING SPECIFIC CREDITS

To add completed PD credit(s):

Click '**+ Add Professional Development**'. A separate window will pop-up.

Complete the required information:

1. Provider or Organization
2. Course Title
3. PD Activity, (Structured Learning, Writing, Research, etc) select the drop down arrow and choose the PD Activity
4. PD Type, (General Education or Health and Safety) select the drop down arrow and choose the PD Type
5. PD Level, (Basic, Intermediate, Advanced) select the drop down arrow and choose the PD Level
6. Select date of completion
7. Add comments
8. Upload a certificate, click and drop a file or click on the blue rectangle to select a file

If the information is incorrect, you can modify the report, or delete the record entirely.

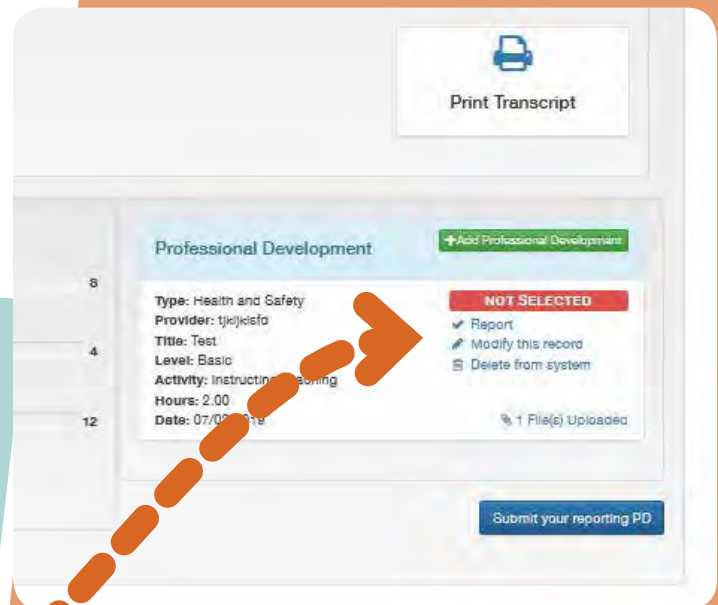

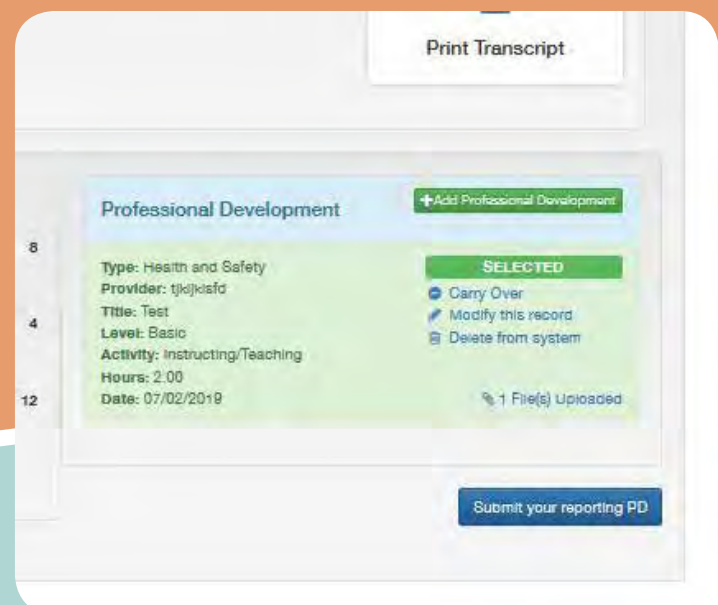
